Technical Procedure for SAFIS Searches and Property Crimes

- **1.0 Purpose** This procedure outlines the guidelines set forth by the Digital/Latent Evidence Section with regard to searching latent prints submitted or developed on property crime cases.
- **2.0 Scope** This procedure applies to property crime cases where latent finger and palmprints are requested to be searched through the SAFIS/AFIT.
 - **2.1** Latent Evidence casework will include requests for a SAFIS search for a property crime where there is no suspect and no elimination prints submitted. There will also be occasions in which the case will be a property crime with a suspect listed and no elimination prints submitted or a suspect listed and victim elimination prints submitted with no SAFIS request made. The guidelines listed below suggest a method for addressing these types of requests.

5.0 Procedure

5.1 Property Crimes with no suspect and no elimination prints submitted or available

- **5.1.1** Evaluate latent prints and, if of value, search through SAFIS.
- **5.1.2** Do not retain prints in the Unsolved Latent Print File (ULF).
- 5.1.3 Add the following statement to the Results Statement Worksheet and Report :

"A search of the SBI Identification Files, based on the information provided, failed to disclose known inked impressions on (victim's name); therefore, no comparison could be conducted between this individual and the (number) identifiable latent finger/palm print(s) noted on (Item numbers)."

And

"The (number) identifiable latent finger/palm print(s) was/were entered into and searched by the AFIS with no identification being effected."

"Due to no elimination prints being submitted for comparison purposes, the (number) identifiable latent finger/palm print(s) was/were not retained in the AFIS database for continual search. Elimination prints must be submitted before any subsequent searches will be conducted."

- 5.2 Property Crimes with a suspect, with or without elimination prints submitted, and no SAFIS request.
 - **5.2.1** Evaluate latent prints.
 - **5.2.2** Compare to subject(s).
 - **5.2.3** The Forensic Scientist, based on his or her training and experience, may search any identifiable latent fingerprint and/or palmprint in SAFIS regardless of whether or not elimination prints have been submitted or a SAFIS search has been requested by the submitting agency on the Request for Examination.
 - **5.2.4** If appropriate, search latent print(s) in SAFIS.
 - 5.2.5 Add the following statement to the Results Statement Worksheet and Report :

"A search of the SBI Identification Files, based on the information provided, failed to disclose known inked impressions on (victim's name); therefore, no comparison could be conducted between this individual and the (number) identifiable latent finger/palm print(s) noted on (Item numbers)." (If applicable based upon the submission of elimination prints).

AND

"The (number) identifiable latent finger/palm print(s) was/were entered into and searched by the AFIS with no identification being effected."

"Due to no elimination prints being submitted for comparison purposes, the (number) identifiable latent finger/palm print(s) was/were not retained in the AFIS database for continual search. Elimination prints must be submitted before any subsequent searches will be conducted."

5.3 Property Crimes involving a business

5.3.1 The requirement of elimination prints from businesses shall be evaluated on a case by case basis, with consideration being given to the number of employees and the logistics of obtaining these prints. Contact the Forensic Scientist Manager or designee with any questions related to this process.
